## Description:

Current COVID 19 Safe Systems of Work (SSW) put in place in March, allow for reduced staff levels due to the Furlough scheme, giving ample space to practice social distancing, hygiene and effective cleaning regimes. With the anticipated return to work of a further 50% of staff, pressure on these safe working practices to maintain a safe workplace for all employees will increase. Further controls will need to be considered in order to maintain a safe workplace and a safe working environment under section 2.1 and 2.2 of the HSAWA 1975. This risk assessment considers options for enhanced safety systems over and above the systems already in place to effectively control the spread of COVID 19 in the workplace.
